Modified ψ -contractive mappings in ordered metric spaces and applications

Abstract

We set up two new variants of ψ -contractive mappings designed for two and three maps in metric spaces and originate common fixed point theorems for \mathcal{T} -strictly weakly isotone increasing mappings and relatively weakly increasing mappings in complete ordered metric spaces. To demonstrate our results, we give some examples throughout the paper. At the same time, as applications of the presented theorems, we get hold of common fixed point results for generalized contractions of integral type and we prove an existence theorem for solutions of a system of integral equations.

1 Introduction and preliminaries

The celebrated Banach's contraction mapping principle [1] is one of the cornerstones in the development of nonlinear analysis. Fixed point theorems have applications not only in the various branches of mathematics, but also in economics, chemistry, biology, computer science, engineering, and other areas. In particular, such theorems are used to demonstrate the existence and uniqueness of solutions of differential equations, integral equations, functional equations, partial differential equations and others. Owing to the magnitude, the generalizations of the Banach fixed point theorem have been explored heavily by many authors (see, *e.g.*, [2] and references cited therein).

Browder and Petryshyn [3] introduced the concept of orbital continuity as well as of asymptotic regularity of a self-map at a point in a metric space. Ćirić [4] introduced the concept of an orbitally complete metric space. Sastry *et al.* [5] extended these concepts to two and three mappings and employed them to prove common fixed point results for commuting mappings. In what follows, we collect such definitions for three maps.

Definition 1 Let S, T, R be three self-mappings defined on a metric space (X, d).

- 1. If for a point $x_0 \in \mathcal{X}$, there exits a sequence $\{x_n\}$ in \mathcal{X} such that $\mathcal{R}x_{2n+1} = \mathcal{S}x_{2n}$, $\mathcal{R}x_{2n+2} = \mathcal{T}x_{2n+1}$, $n = 0, 1, 2, \ldots$, then the set $\mathcal{O}(x_0; \mathcal{S}, \mathcal{T}, \mathcal{R}) = \{\mathcal{R}x_n : n = 1, 2, \ldots\}$ is called the orbit of $(\mathcal{S}, \mathcal{T}, \mathcal{R})$ at x_0 .
- 2. The space (\mathcal{X}, d) is said to be $(\mathcal{S}, \mathcal{T}, \mathcal{R})$ -orbitally complete at x_0 if every Cauchy sequence in $\mathcal{O}(x_0; \mathcal{S}, \mathcal{T}, \mathcal{R})$ converges in \mathcal{X} .



- 3. The map \mathcal{R} is said to be orbitally continuous at x_0 if it is continuous on $\mathcal{O}(x_0; \mathcal{S}, \mathcal{T}, \mathcal{R})$.
- 4. The pair (S, T) is said to be asymptotically regular (in short a.r.) with respect to \mathcal{R} at x_0 if there exists a sequence $\{x_n\}$ in \mathcal{X} such that $\mathcal{R}x_{2n+1} = Sx_{2n}$, $\mathcal{R}x_{2n+2} = Tx_{2n+1}$, $n = 0, 1, 2, \ldots$, and $d(\mathcal{R}x_n, \mathcal{R}x_{n+1}) \to 0$ as $n \to \infty$.
- 5. If \mathcal{R} is the identity mapping on \mathcal{X} , we omit \mathcal{R} in respective definitions.

On the other hand, fixed point theory has developed rapidly in metric spaces endowed with a partial ordering. The foremost result in this direction was given by Ran and Reurings [6] who presented its applications to matrix equations. Subsequently, Nieto and Rodríguez-López [7] extended this result for nondecreasing mappings and applied it to obtain a unique solution for a first-order ordinary differential equation with periodic boundary conditions. From then on, a number of authors have obtained many fixed point theorems in ordered metric spaces. For more details, see, *e.g.*, [8–12] and the references cited therein. Many good quality works have been produced by the authors like Aydi, Karapinar, and Shatanawi in this area. Very recently, Chen [13] introduced ψ -contractive mappings (see Definition 5) and proved some fixed point theorems in an ordered metric space, thus extending and improving the results given in [14]. One of the main results in [13] is the following theorem.

Theorem 1 Let $(\mathcal{X}, d, \preceq)$ be a complete partially ordered metric space such that for each nondecreasing sequence $\{x_n\}$ in \mathcal{X} converging to $z \in \mathcal{X}$, $x_n \preceq z$ holds for each $n \in \mathbb{N}$. Suppose that $\mathcal{T}: \mathcal{X} \to \mathcal{X}$ is a nondecreasing ψ -contractive self-map. If there exists an $x_0 \in \mathcal{X}$ such that $x_0 \preceq \mathcal{T} x_0$, then \mathcal{T} has a fixed point in \mathcal{X} .

In this paper, we extend the results of Chen [13] (and hence some other related common fixed point results) in two directions. The first is treated in Section 3, where the notion of a ψ_S -contractive condition is introduced in metric spaces. The existence and (under additional assumptions) uniqueness of common fixed points is obtained under the assumptions that respective mappings are strictly weakly isotone increasing and that they satisfy the ψ_S -contractive condition. In Section 4, we consider the case of three self-mappings $\mathcal{S}, \mathcal{T}, \mathcal{R}$ where the pair $(\mathcal{S}, \mathcal{T})$ is \mathcal{R} -relatively asymptotically regular and relatively weakly increasing, while the new contractive condition, named $\psi_{\mathcal{S},\mathcal{R}}$ -contraction, is established.

We supply appropriate examples to make the validity of the propositions of our results obvious. To end with, as applications of the presented theorems, we achieve common fixed point results for generalized contractions of integral type and we prove the existence theorem for solutions of a system of integral equations.

2 Notation and definitions

All the way through this paper, by \mathbb{R}^+ we designate the set of nonnegative real numbers, while \mathbb{N} is the set of natural numbers and $\mathbb{N}_0 = \mathbb{N} \cup \{0\}$.

First, we introduce some further notation and definitions that will be used later.

If (\mathcal{X}, \leq) is a partially ordered set, then $x, y \in \mathcal{X}$ are called comparable if $x \leq y$ or $y \leq x$ holds. A subset \mathcal{K} of \mathcal{X} is said to be totally ordered if every two elements of \mathcal{K} are comparable. If $\mathcal{T}: \mathcal{X} \to \mathcal{X}$ is such that, for $x, y \in \mathcal{X}$, $x \leq y$ implies $\mathcal{T}x \leq \mathcal{T}y$, then the mapping \mathcal{T} is said to be nondecreasing.

Definition 2 Let (\mathcal{X}, \preceq) be a partially ordered set and $\mathcal{S}, \mathcal{T} : \mathcal{X} \to \mathcal{X}$.

- 1. [15, 16] The pair (S, T) is called weakly increasing if $Sx \leq TSx$ and $Tx \leq STx$ for all $x \in \mathcal{X}$.
- 2. [15–17] The mapping S is said to be T-weakly isotone increasing if for all $x \in \mathcal{X}$, we have $Sx \preceq TSx \preceq STSx$.
- 3. [18] The mapping S is said to be T-strictly weakly isotone increasing if for all $x \in \mathcal{X}$ such that $x \prec Sx$, we have $Sx \prec TSx \prec STSx$.
- 4. [11] Let $\mathcal{R}: \mathcal{X} \to \mathcal{X}$ be such that $\mathcal{TX} \subseteq \mathcal{RX}$ and $\mathcal{SX} \subseteq \mathcal{RX}$, and denote $\mathcal{R}^{-1}(x) := \{u \in \mathcal{X}: \mathcal{R}u = x\}$ for $x \in \mathcal{X}$. We say that \mathcal{T} and \mathcal{S} are weakly increasing with respect to \mathcal{R} if for all $x \in \mathcal{X}$, we have

$$\mathcal{T}x \leq \mathcal{S}y$$
, $\forall y \in \mathcal{R}^{-1}(\mathcal{T}x)$ and $\mathcal{S}x \leq \mathcal{T}y$, $\forall y \in \mathcal{R}^{-1}(\mathcal{S}x)$.

5. [19] The mapping \mathcal{T} is called dominating if $x \leq \mathcal{T}x$ for each x in \mathcal{X} .

Remark 1 (1) None of two weakly increasing mappings need to be nondecreasing. There exist some examples to illustrate this fact in [20].

- (2) If $S, T : X \to X$ are weakly increasing, then S is T-weakly isotone increasing and hence S can be T-strictly weakly isotone increasing.
- (3) S can be T-strictly weakly isotone increasing, while some of these two mappings can be not strictly increasing (see the following example).
- (4) If \mathcal{R} is the identity mapping ($\mathcal{R}x = x$ for all $x \in \mathcal{X}$), then \mathcal{T} and \mathcal{S} are weakly increasing with respect to \mathcal{R} if and only if they are weakly increasing mappings.

Example 1 Let $\mathcal{X} = [0, +\infty)$ be endowed with the usual ordering and define $\mathcal{S}, \mathcal{T} : \mathcal{X} \to \mathcal{X}$ as

$$Sx = \begin{cases} 2x, & \text{if } x \in [0,1], \\ 3x, & \text{if } x > 1; \end{cases} \qquad Tx = \begin{cases} 2, & \text{if } x \in [0,1], \\ 2x, & \text{if } x > 1. \end{cases}$$

Clearly, we have $x \prec Sx \prec TSx \prec STSx$ for all $x \in \mathcal{X}$, and so, S is T-strictly weakly isotone increasing; T is not strictly increasing.

Definition 3 ([21, 22]) Let (\mathcal{X}, d) be a metric space and $f, g : \mathcal{X} \to \mathcal{X}$. The mappings f and g are said to be compatible if $\lim_{n\to\infty} d(fgx_n, gfx_n) = 0$, whenever $\{x_n\}$ is a sequence in \mathcal{X} such that $\lim_{n\to\infty} fx_n = \lim_{n\to\infty} gx_n = t$ for some $t \in \mathcal{X}$.

Definition 4 Let \mathcal{X} be a nonempty set. Then $(\mathcal{X}, d, \preceq)$ is called an ordered metric space if

- (i) (\mathcal{X}, d) is a metric space,
- (ii) (\mathcal{X}, \leq) is a partially ordered set.

The space $(\mathcal{X}, d, \preceq)$ is called regular if the following hypothesis holds: if $\{z_n\}$ is a nondecreasing sequence in \mathcal{X} with respect to \preceq such that $z_n \to z \in \mathcal{X}$ as $n \to \infty$, then $z_n \preceq z$.

3 Common fixed points for generalized $\psi_{\mathcal{S}}$ -contractive mappings

Inspired by the notion of a ψ -contractive mapping given in [13], we first introduce the notion of ψ_S -contractive mappings in metric spaces.

For convenience, we denote by **F** the class of functions $\psi : \mathbb{R}^{+5} \to \mathbb{R}^+$ satisfying the following conditions:

- (C_1) ψ is a strictly increasing and continuous function in each coordinate, and
- (C₂) for all $t \in \mathbb{R}^+ \setminus \{0\}$, $\psi(t,t,t,0,2t) < t$, $\psi(t,t,t,2t,0) < t$, $\psi(0,0,t,t,0) < t$, $\psi(0,t,0,0,t,t) < t$.

The following are some easy examples of functions from class **F**:

$$\begin{split} &\psi(t_1,t_2,t_3,t_4,t_5) = k \max\left\{t_1,t_2,t_3,\frac{t_4}{2},\frac{t_5}{2}\right\}, \quad \text{for } k \in (0,1); \\ &\psi(t_1,t_2,t_3,t_4,t_5) = k \max\left\{t_1,t_2,t_3,\frac{t_4+t_5}{2}\right\}, \quad \text{for } k \in (0,1); \\ &\psi(t_1,t_2,t_3,t_4,t_5) = At_1 + Bt_2 + Ct_3 + D\frac{t_4+t_5}{2}, \quad \text{for } A,B,C,D \geq 0, A+B+C+D < 1. \end{split}$$

Definition 5 Let (\mathcal{X}, d, \leq) be an ordered metric space, and let $\mathcal{T}, \mathcal{S} : \mathcal{X} \to \mathcal{X}$. The mappings \mathcal{T}, \mathcal{S} are said to be $\psi_{\mathcal{S}}$ -contractive if

$$d(\mathcal{T}x,\mathcal{S}y) \le \psi\left(d(x,y),d(x,\mathcal{T}x),d(y,\mathcal{S}y),d(x,\mathcal{S}y),d(y,\mathcal{T}x)\right) \quad \text{for } x \succeq y,\tag{3.1}$$

where $\psi \in \mathbf{F}$.

For S = T, this definition reduces to the definition of a ψ -contractive mapping from [13]. It is easy to acquire the following examples of ψ_S -contractive mappings.

Example 2 Let $\mathcal{X} = \mathbb{R}^+$ be endowed with usual metric and ordering, and let $\psi : \mathbb{R}^{+5} \to \mathbb{R}^+$ be given by

$$\psi(t_1, t_2, t_3, t_4, t_5) = \frac{3}{4} \max \left\{ t_1, t_2, t_3, \frac{t_4 + t_5}{2} \right\}.$$

If $\mathcal{T}, \mathcal{S}: \mathcal{X} \to \mathcal{X}$ are defined by $\mathcal{T}x = \frac{1}{3}x$ and $\mathcal{S}x = \frac{1}{2}x$, then \mathcal{T}, \mathcal{S} are $\psi_{\mathcal{S}}$ -contractive mappings.

Example 3 Let $\mathcal{X} = \mathbb{R}^+ \times \mathbb{R}^+$ be endowed with the coordinate ordering (*i.e.*, $(x_1, y_1) \le (x_2, y_2) \Leftrightarrow x_1 \le x_2$ and $y_1 \le y_2$) and with the metric $d : \mathcal{X} \times \mathcal{X} \to \mathbb{R}^+$ given by

$$d(x,y) = |x_1 - y_1| + |x_2 - y_2|$$
, for $x = (x_1, x_2), y = (y_1, y_2) \in \mathcal{X}$.

Let $\psi : \mathbb{R}^{+5} \to \mathbb{R}^+$ be given by

$$\psi(t_1,t_2,t_3,t_4,t_5) = \frac{3}{4} \max \left\{ t_1,t_2,t_3,\frac{t_4}{2},\frac{t_5}{2} \right\},\,$$

and $\mathcal{T}, \mathcal{S}: \mathcal{X} \to \mathcal{X}$ be given by

$$\mathcal{T}(x,y) = \left(\frac{1}{3}x, \frac{1}{3}y\right)$$
 and $\mathcal{S}(x,y) = \left(\frac{1}{2}x, \frac{1}{2}y\right)$.

Then \mathcal{T} , \mathcal{S} are $\psi_{\mathcal{S}}$ -contractive mappings.

Now, we state and prove our first result.

Theorem 2 Let $(\mathcal{X}, d, \preceq)$ be a complete ordered metric space. Suppose that $\mathcal{T}, \mathcal{S} : \mathcal{X} \to \mathcal{X}$ are two mappings satisfying the $\psi_{\mathcal{S}}$ -contractive condition (3.1) for all comparable $x, y \in \mathcal{X}$.

We assume the following hypotheses:

- (i) S is T-strictly weakly isotone increasing;
- (ii) there exists an $x_0 \in \mathcal{X}$ such that $x_0 \prec \mathcal{S}x_0$;
- (iii) S or T is continuous at x_0 .

Then S and T have a common fixed point. Moreover, the set of common fixed points of S, T is totally ordered if and only if S and T have one and only one common fixed point.

Proof First of all, we show that if S or T has a fixed point, then it is a common fixed point of S and T. Indeed, let z be a fixed point of S. Assume that d(z, Tz) > 0. If we use the inequality (3.1), for x = y = z, we have

$$d(\mathcal{T}z,z) = d(\mathcal{T}z,\mathcal{S}z) \le \psi \left(d(z,z), d(z,\mathcal{T}z), d(z,\mathcal{S}z), d(z,\mathcal{S}z), d(z,\mathcal{T}z) \right)$$
$$= \psi \left(0, d(z,\mathcal{T}z), 0, 0, d(z,\mathcal{T}z) \right) < d(z,\mathcal{T}z),$$

which is a contradiction. Thus, $d(z, \mathcal{T}z) = 0$ and so z is a common fixed point of \mathcal{S} and \mathcal{T} . Analogously, one can observe that if z is a fixed point of \mathcal{T} , then it is a common fixed point of \mathcal{S} and \mathcal{T} .

Let x_0 be such that $x_0 \prec Sx_0$. We can define a sequence $\{x_n\}$ in \mathcal{X} as follows:

$$x_{2n+1} = Sx_{2n}$$
 and $x_{2n+2} = Tx_{2n+1}$ for $n \in \{0,1,\ldots\}$.

Since S is T-strictly weakly isotone increasing, we have

$$x_1 = Sx_0 \prec TSx_0 = Tx_1 = x_2 \prec STSx_0 = STx_1 = Sx_2 = x_3,$$

 $x_3 = Sx_2 \prec TSx_2 = Tx_3 = x_4 \prec STSx_2 = STx_3 = Sx_4 = x_5,$

and continuing this process, we get

$$x_1 \prec x_2 \prec \cdots \prec x_n \prec x_{n+1} \prec \cdots \tag{3.2}$$

Now, we claim that for all $n \in \mathbb{N}$, we have

$$d(x_{n+1}, x_{n+2}) < d(x_n, x_{n+1}). (3.3)$$

Suppose to the contrary that, *e.g.*, $d(x_{2n}, x_{2n+1}) \le d(x_{2n+1}, x_{2n+2})$ for some $n \in \mathbb{N}$. From (3.2) we have that $x_{2n} \prec x_{2n+1}$ for all $n \in \mathbb{N}$. Then from (3.1) with $x = x_{2n+1}$ and $y = x_{2n}$, we get

$$\begin{aligned} d(x_{2n+2},x_{2n+1}) &= d(\mathcal{T}x_{2n+1},\mathcal{S}x_{2n}) \\ &\leq \psi \left(d(x_{2n+1},x_{2n}), d(x_{2n+1},\mathcal{T}x_{2n+1}), d(x_{2n},\mathcal{S}x_{2n}), \right. \\ &\left. d(x_{2n+1},\mathcal{S}x_{2n}), d(x_{2n},\mathcal{T}x_{2n+1}) \right) \end{aligned}$$

$$= \psi \left(d(x_{2n+1}, x_{2n}), d(x_{2n+1}, x_{2n+2}), d(x_{2n}, x_{2n+1}), d(x_{2n+1}, x_{2n+1}), d(x_{2n+1}, x_{2n+1}), d(x_{2n}, x_{2n+2}) \right)$$

$$\leq \psi \left(d(x_{2n+1}, x_{2n}), d(x_{2n+1}, x_{2n+2}), d(x_{2n}, x_{2n+1}), d(x_{2n}, x_{2n+1}), d(x_{2n}, x_{2n+1}), d(x_{2n+1}, x_{2n+2}) \right)$$

$$\leq \psi \left(d(x_{2n+1}, x_{2n+2}), d(x_{2n+1}, x_{2n+2}), d(x_{2n+1}, x_{2n+2}), 0, 2d(x_{2n+1}, x_{2n+2}) \right)$$

$$< d(x_{2n+1}, x_{2n+2}), d(x_{2n+1}, x_{2n+2}), d(x_{2n+1}, x_{2n+2})$$

a contradiction. Hence, we deduce that for each $n \in \mathbb{N}$,

$$d(x_{2n+2},x_{2n+1}) < d(x_{2n+1},x_{2n}).$$

Similarly, we can prove that $d(x_{2n+1}, x_{2n}) < d(x_{2n}, x_{2n-1})$ for all $n \ge 1$. Therefore, we conclude that (3.3) holds.

Let us denote $c_n = d(x_{n+1}, x_n)$. Then from (3.3), c_n is a nonincreasing sequence and bounded below. Thus, it must converge to some $c \ge 0$. If c > 0, then similarly as above (e.g., for n = 2k), we have

$$c_{n+1} \leq \psi(c_n, c_{n+1}, c_n, 0, 2c_n).$$

Passing to the limit as $n \to \infty$, we have

$$c \leq \psi(c, c, c, 0, 2c) < c,$$

which is a contradiction. Hence,

$$\lim_{n \to \infty} d(x_{n+1}, x_n) = 0. \tag{3.4}$$

Next, we claim that $\{x_n\}$ is a Cauchy sequence. From (3.4), it will be sufficient to show that $\{x_{2n}\}$ is a Cauchy sequence. We proceed with negation and suppose that $\{x_{2n}\}$ is not Cauchy. Then we can find a $\delta > 0$ such that for each even integer 2k, there exist even integers $2m_k > 2n_k > 2k$ such that

$$d(x_{2n_k}, x_{2m_k}) \ge \delta$$
 for $k \in \{1, 2, ...\}.$ (3.5)

We may also assume

$$d(x_{2n_k}, x_{2m_k-2}) < \delta \tag{3.6}$$

by choosing $2m_k$ to be the smallest number exceeding $2n_k$ for which (3.5) holds. Now (3.4), (3.5), and (3.6) imply

$$0 < \delta \le d(x_{2n_k}, x_{2m_k}) \le d(x_{2n_k}, x_{2m_k-2}) + d(x_{2m_k-2}, x_{2m_k-1}) + d(x_{2m_k-1}, x_{2m_k})$$
$$< \delta + d(x_{2m_k-2}, x_{2m_k-1}) + d(x_{2m_k-1}, x_{2m_k}) \to \delta, \quad \text{as } k \to \infty,$$

and hence

$$\lim_{k\to\infty}d(x_{2n_k},x_{2m_k})=\delta.$$

Also, by the triangular inequality,

$$\left| d(x_{2n_k}, x_{2m_k-1}) - d(x_{2n_k}, x_{2m_k}) \right| \le d(x_{2m_k-1}, x_{2m_k})$$

and

$$|d(x_{2n_k+1}, x_{2m_k-1}) - d(x_{2n_k}, x_{2m_k})|$$

$$\leq d(x_{2m_k-1}, x_{2m_k}) + d(x_{2n_k}, x_{2n_k+1}).$$

Therefore, we get

$$\lim_{k\to\infty}d(x_{2n_k},x_{2m_k-1})=\delta$$

and

$$\lim_{k\to\infty}d(x_{2n_k+1},x_{2m_k-1})=\delta.$$

Since \mathcal{T} , \mathcal{S} are $\psi_{\mathcal{S}}$ -contractive mappings, we also have

$$\begin{split} \delta &\leq d(x_{2n_k}, x_{2m_k}) \\ &\leq d(x_{2n_k}, x_{2n_k+1}) + d(x_{2n_k+1}, x_{2m_k}) \\ &= d(x_{2n_k}, x_{2n_k+1}) + d(\mathcal{T}x_{2m_k-1}, \mathcal{S}x_{2n_k}) \\ &\leq d(x_{2n_k}, x_{2n_k+1}) + \psi\left(d(x_{2m_k-1}, x_{2n_k}), d(x_{2m_k-1}, x_{2m_k}), d(x_{2m_k}, x_{2n_k+1}), d(x_{2m_k-1}, x_{2n_k+1}), d(x_{2m_k}, x_{2n_k})\right). \end{split}$$

Passing to the limit as $k \to \infty$, we get

$$\delta \leq 0 + \psi(\delta, 0, 0, \delta, \delta) < \delta$$
,

a contradiction. It follows that $\{x_n\}$ must be a Cauchy sequence.

Since \mathcal{X} is complete, there exists $z \in \mathcal{X}$ such that $\lim_{n \to \infty} x_n = z$. Moreover, the continuity of \mathcal{T} implies that

$$z = \lim_{n \to \infty} x_{n+1} = \lim_{n \to \infty} \mathcal{T} x_n = \mathcal{T} z.$$

Similarly, if S is continuous, we have that Sz = z. Using the argument from the beginning of the proof, we conclude that S and T have a common fixed point.

Now, suppose that the set of common fixed points of \mathcal{T} and \mathcal{S} is totally ordered. We claim that there is a unique common fixed point of \mathcal{T} and \mathcal{S} . Assume to the contrary that

Su = Tu = u and Sv = Tv = v, but $u \neq v$. By supposition, we can replace x by u and y by v in (3.1), and by the continuity of ψ , we obtain

$$d(v,u) = d(\mathcal{T}v, \mathcal{S}u) \le \psi(d(v,u), d(v, \mathcal{T}v), d(u, \mathcal{S}u), d(v, \mathcal{S}u), d(u, \mathcal{T}v))$$

$$\le \psi(d(v,u), 0, 0, d(v,u), d(u,v)) < d(v,u),$$

a contradiction. Hence, u = v. The converse is trivial. So, we have completed the proof.

We are also able to prove the existence of a common fixed point of two mappings without using the continuity of S or T. More precisely, we have the following theorem.

Theorem 3 Let (\mathcal{X}, d, \leq) and $\mathcal{S}, \mathcal{T} : \mathcal{X} \to \mathcal{X}$ satisfy all the conditions of Theorem 2, except that the condition (iii) is substituted by

(iii') \mathcal{X} is regular.

Then the same conclusions as in Theorem 2 hold.

Proof Following the proof of Theorem 2, we have that $\{x_n\}$ is a Cauchy sequence in (\mathcal{X}, d) which is complete. Then there exists $z \in \mathcal{X}$ such that

$$\lim_{n\to\infty}x_n=z.$$

Now suppose that d(z, Sz) > 0. From regularity of \mathcal{X} , we have $x_{2n} \leq z$ for all $n \in \mathbb{N}$. Hence, we can apply the considered contractive condition. Then setting $x = x_{2n+1}$ and y = z in (3.1), we obtain

$$d(x_{2n+2}, Sz) = d(\mathcal{T}x_{2n+1}, Sz)$$

$$\leq \psi \left(d(x_{2n+1}, z), d(x_{2n+1}, \mathcal{T}x_{2n+1}), d(z, Sz), d(x_{2n+1}, Sz), d(z, \mathcal{T}x_{2n+1}) \right)$$

$$\leq \psi \left(d(x_{2n+1}, z), d(x_{2n+1}, x_{2n+2}), d(z, Sz), d(x_{2n+1}, Sz), d(z, x_{2n+2}) \right).$$

Passing to the limit as $n \to \infty$ and using the properties of ψ , we have

$$d(z,Sz) \leq \psi(0,0,d(z,Sz),d(z,Sz),0) < d(z,Sz),$$

and this is a contradiction. Hence, d(z, Sz) = 0, *i.e.*, z = Sz. Analogously, for x = z and $y = x_{2n}$, one can prove that Tz = z. It follows that z = Sz = Tz, that is, T and S have a common fixed point.

Corollary 1 Let (X, d, \preceq) be a complete ordered metric space. Suppose $T, S : X \to X$ are two mappings satisfying the ψ_S -contractive condition for all comparable $x, y \in X$.

We assume the following hypotheses:

- (i') S and T are weakly increasing;
- (iii') \mathcal{X} is regular.

Then S and T have a common fixed point. Moreover, the set of common fixed points of S, T is totally ordered if and only if S and T have one and only one common fixed point.

Putting S = T in Theorem 2 and Theorem 3, we obtain easily the following result.

Corollary 2 Let $(\mathcal{X}, d, \preceq)$ be a complete ordered metric space. Suppose $\mathcal{T}: \mathcal{X} \to \mathcal{X}$ is a mapping satisfying the ψ -contractive condition for all comparable $x, y \in \mathcal{X}$. Also suppose that $\mathcal{T}x \prec \mathcal{T}(\mathcal{T}x)$ for all $x \in \mathcal{X}$ such that $x \prec \mathcal{T}x$. If there exists an $x_0 \in \mathcal{X}$ such that $x_0 \prec \mathcal{T}x_0$ and the condition

 ${\mathcal T}$ is continuous, or ${\mathcal X}$ is regular

holds, then T has a fixed point. Moreover, the set of fixed points of T is totally ordered if and only if it is a singleton.

We present an example showing how our results can be used.

Example 4 Let the set $\mathcal{X} = [0, +\infty)$ be equipped with the usual metric d and the order defined by

$$x \leq y \iff x = y \vee (x, y \in [0, 1] \land x \geq y).$$

Consider the following self-mappings on \mathcal{X} :

$$\mathcal{T}x = \begin{cases} \frac{2}{3} + \frac{1}{3}x, & 0 \le x \le 1, \\ 3x - 2, & x > 1, \end{cases} \qquad \mathcal{S}x = \begin{cases} \frac{1}{2} + \frac{1}{2}x, & 0 \le x \le 1, \\ 2x - 1, & x > 1. \end{cases}$$

Take $\psi \in \mathbf{F}$ given by

$$\psi(t_1,t_2,t_3,t_4,t_5) = \frac{5}{6} \max \left\{ t_1,t_2,t_3,\frac{t_4+t_5}{2} \right\}.$$

Then it is easy to show that all the conditions of Theorem 2 are fulfilled. The contractive condition (3.1) is trivially satisfied if x = y. Suppose that $x \succeq y$ and $0 \le x, y \le 1$, *i.e.*, $x \le y$. Then (3.1) takes the form

$$\begin{aligned} & \left| \frac{1}{6} + \frac{1}{3}x - \frac{1}{2}y \right| \\ & \leq \frac{5}{6} \max \left\{ |x - y|, \frac{2}{3}|x - 1|, \frac{1}{2}|y - 1|, \frac{1}{2} \left[\left| x - \frac{1}{2} - \frac{1}{2}y \right| + \left| y - \frac{2}{3} - \frac{1}{3}x \right| \right] \right\}. \end{aligned}$$

Using substitution $x = 1 - \xi$, $y = 1 - \xi t$, $0 \le \xi \le 1$, $t \ge 0$, the last inequality reduces to

$$|3t-2| \le 5 \max \left\{ |1-t|, \frac{2}{3}, \frac{1}{2}t, \frac{1}{2} \left[\left| \frac{1}{2}t-1 \right| + \left| t-\frac{1}{3} \right| \right] \right\},$$

and can be checked by discussion on possible values for $t \ge 0$. Hence, all the conditions of Theorem 2 are satisfied and S, T have a common fixed point (which is z = 1).

4 Common fixed points for $\psi_{S,R}$ -contractive mappings

In this section, we generalize and improve the results of Section 3 (hence results given in [13]) for three maps (under additional conditions).

For this, we first introduce the notion of $\psi_{S,R}$ -contraction in metric spaces.

Definition 6 Let (\mathcal{X}, d) be a metric space. Mappings $\mathcal{T}, \mathcal{S}, \mathcal{R} : \mathcal{X} \to \mathcal{X}$ are called $\psi_{\mathcal{S}, \mathcal{R}}$ -contractive if

$$d(\mathcal{T}x,\mathcal{S}y) < \psi(d(\mathcal{R}x,\mathcal{R}y),d(\mathcal{R}x,\mathcal{T}x),d(\mathcal{R}y,\mathcal{S}y),d(\mathcal{R}x,\mathcal{S}y),d(\mathcal{R}y,\mathcal{T}x)), \tag{4.1}$$

for $\Re x \succeq \Re y$, where $\psi \in \mathbf{F}$.

It is easy to acquire the following example of $\psi_{S,R}$ -contractive mappings.

Example 5 Let $\mathcal{X} = \mathbb{R}^+$ be endowed with standard metric and order. Let $\psi : \mathbb{R}^{+5} \to \mathbb{R}^+$ be given by

$$\psi(t_1,t_2,t_3,t_4,t_5) = \frac{3}{4} \max \left\{ t_1,t_2,t_3,\frac{t_4}{2},\frac{t_5}{2} \right\},\,$$

and let $\mathcal{T}, \mathcal{S}, \mathcal{R}: \mathcal{X} \to \mathcal{X}$ be defined as

$$\mathcal{T}x = \frac{1}{5}x$$
, $Sx = \frac{1}{2}x$ and $\mathcal{R}x = 10x$.

Then \mathcal{T} , \mathcal{S} , \mathcal{R} are $\psi_{\mathcal{S},\mathcal{R}}$ -contractive mappings.

Now, we state and prove our second main result.

Theorem 4 Let $(\mathcal{X}, d, \preceq)$ be an ordered metric space, and let \mathcal{T}, \mathcal{S} , and \mathcal{R} be self-maps on \mathcal{X} satisfying the $\psi_{\mathcal{S},\mathcal{R}}$ -contractive condition for every pair $(x,y) \in \mathcal{O}(x_0; \mathcal{S}, \mathcal{T}, \mathcal{R}) \times \mathcal{O}(x_0; \mathcal{S}, \mathcal{T}, \mathcal{R})$ (for some x_0) such that $\mathcal{R}x$ and $\mathcal{R}y$ are comparable.

We assume the following hypotheses:

- (i) (S, T) is a.r. with respect to R at $x_0 \in X$;
- (ii) \mathcal{X} is $(\mathcal{S}, \mathcal{T}, \mathcal{R})$ -orbitally complete at x_0 ;
- (iii) T and S are weakly increasing with respect to R;
- (iv) T and S are dominating maps.

Assume either

- (a) S and R are compatible; S or R is orbitally continuous at x_0 or
- (b) \mathcal{T} and \mathcal{R} are compatible; \mathcal{T} or \mathcal{R} is orbitally continuous at x_0 .

Then S, T, and R have a common fixed point. Moreover, the set of common fixed points of S, T, and R is well ordered if and only if S, T, and R have one and only one common fixed point.

Proof Since (S, T) is a.r. with respect to R at x_0 in X, there exists a sequence $\{x_n\}$ in X such that

$$\mathcal{R}x_{2n+1} = \mathcal{S}x_{2n}, \qquad \mathcal{R}x_{2n+2} = \mathcal{T}x_{2n+1}, \quad \forall n \in \mathbb{N}_0, \tag{4.2}$$

and

$$\lim_{n \to \infty} d(\mathcal{R}x_n, \mathcal{R}x_{n+1}) = 0 \tag{4.3}$$

holds. We claim that

$$\mathcal{R}x_n \leq \mathcal{R}x_{n+1}, \quad \forall n \in \mathbb{N}_0.$$
 (4.4)

To this aim, we will use the increasing property with respect to \mathcal{R} satisfied by the mappings \mathcal{T} and \mathcal{S} . From (4.2), we have

$$\mathcal{R}x_1 = \mathcal{S}x_0 \leq \mathcal{T}y$$
, $\forall y \in \mathcal{R}^{-1}(\mathcal{S}x_0)$.

Since $\Re x_1 = \Im x_0$, $x_1 \in \Re^{-1}(\Im x_0)$ and we get

$$\mathcal{R}x_1 = \mathcal{S}x_0 \prec \mathcal{T}x_1 = \mathcal{R}x_2$$
.

Again,

$$\mathcal{R}x_2 = \mathcal{T}x_1 \leq \mathcal{S}y, \quad \forall y \in \mathcal{R}^{-1}(\mathcal{T}x_1).$$

Since $x_2 \in \mathcal{R}^{-1}(\mathcal{T}x_1)$, we get

$$\mathcal{R}x_2 = \mathcal{T}x_1 \prec \mathcal{S}x_2 = \mathcal{R}x_3$$
.

Hence, by induction, (4.4) holds. Therefore, we can apply (4.1) for $x = x_p$ and $y = x_q$ for all p and q.

Next, we claim that $\{\mathcal{R}x_n\}$ is a Cauchy sequence. From (4.3), it will be sufficient to show that $\{\mathcal{R}x_{2n}\}$ is a Cauchy sequence. We proceed with negation and suppose that $\{\mathcal{R}x_{2n}\}$ is not Cauchy. Then we can find a $\delta > 0$ such that for each even integer 2k, there exist even integers $2m_k > 2n_k > 2k$ such that

$$d(\mathcal{R}x_{2n_k}, \mathcal{R}x_{2m_k}) \ge \delta \quad \text{for } k \in \{1, 2, \ldots\}.$$

$$\tag{4.5}$$

We may also assume

$$d(\mathcal{R}x_{2n_k}, \mathcal{R}x_{2m_k-2}) < \delta \tag{4.6}$$

by choosing $2m_k$ to be the smallest number exceeding $2n_k$ for which (4.5) holds. Now (4.3), (4.5), and (4.6) imply

$$0 < \delta \le d(\mathcal{R}x_{2n_k}, \mathcal{R}x_{2m_k})$$

$$\le d(\mathcal{R}x_{2n_k}, \mathcal{R}x_{2m_k-2}) + d(\mathcal{R}x_{2m_k-2}, \mathcal{R}x_{2m_k-1}) + d(\mathcal{R}x_{2m_k-1}, \mathcal{R}x_{2m_k})$$

$$< \delta + d(\mathcal{R}x_{2m_k-2}, \mathcal{R}x_{2m_k-1}) + d(\mathcal{R}x_{2m_k-1}, \mathcal{R}x_{2m_k}) \to \delta, \quad \text{as } k \to \infty,$$

and hence

$$\lim_{k\to\infty}d(\mathcal{R}x_{2n_k},\mathcal{R}x_{2m_k})=\delta.$$

Also, by the triangular inequality,

$$|d(\mathcal{R}x_{2n_k}, \mathcal{R}x_{2m_k-1}) - d(\mathcal{R}x_{2n_k}, \mathcal{R}x_{2m_k})| \le d(\mathcal{R}x_{2m_k-1}, \mathcal{R}x_{2m_k})$$

and

$$\begin{aligned} \left| d(\mathcal{R}x_{2n_k+1}, \mathcal{R}x_{2m_k-1}) - d(\mathcal{R}x_{2n_k}, \mathcal{R}x_{2m_k}) \right| \\ &\leq d(\mathcal{R}x_{2m_k-1}, \mathcal{R}x_{2m_k}) + d(\mathcal{R}x_{2n_k}, \mathcal{R}x_{2n_k+1}). \end{aligned}$$

Therefore, we get

$$\lim_{k\to\infty} d(\mathcal{R}x_{2n_k}, \mathcal{R}x_{2m_k-1}) = \delta$$

and

$$\lim_{k\to\infty} d(\mathcal{R}x_{2n_k+1}, \mathcal{R}x_{2m_k-1}) = \delta.$$

Since \mathcal{T} , \mathcal{S} , \mathcal{R} are $\psi_{\mathcal{S},\mathcal{R}}$ -contractive mappings, we also have

$$\begin{split} \delta &\leq d(\mathcal{R}x_{2n_k}, \mathcal{R}x_{2m_k}) \leq d(\mathcal{R}x_{2n_k}, \mathcal{R}x_{2n_k+1}) + d(\mathcal{R}x_{2n_k+1}, \mathcal{R}x_{2m_k}) \\ &= d(\mathcal{R}x_{2n_k}, \mathcal{R}x_{2n_k+1}) + d(\mathcal{T}x_{2m_k-1}, \mathcal{S}x_{2n_k}) \\ &\leq d(\mathcal{R}x_{2n_k}, \mathcal{R}x_{2n_k+1}) + \psi \Big(d(\mathcal{R}x_{2m_k-1}, \mathcal{R}x_{2n_k}), d(\mathcal{R}x_{2m_k-1}, \mathcal{R}x_{2m_k}), \\ d(\mathcal{R}x_{2n_k}, \mathcal{R}x_{2n_k+1}), d(\mathcal{R}x_{2m_k-1}, \mathcal{R}x_{2n_k+1}), d(\mathcal{R}x_{2m_k}, \mathcal{R}x_{2n_k}) \Big). \end{split}$$

Passing to the limit as $k \to \infty$, we get

$$\delta < 0 + \psi(\delta, 0, 0, \delta, \delta) < \delta$$

a contradiction. It follows that $\{\mathcal{R}x_n\}$ must be a Cauchy sequence.

Since \mathcal{X} is $(\mathcal{S}, \mathcal{T}, \mathcal{R})$ -orbitally complete at x_0 , there exists some $z \in \mathcal{X}$ such that

$$\mathcal{R}x_n \to z \quad \text{as } n \to \infty.$$
 (4.7)

We will prove that z is a common fixed point of the three mappings S, T, and R. We have

$$\mathcal{R}x_{2n+1} = \mathcal{S}x_{2n} \to z \quad \text{as } n \to \infty$$

and

$$\mathcal{R}x_{2n+2} = \mathcal{T}x_{2n+1} \to z \quad \text{as } n \to \infty.$$

Suppose that (a) holds; *e.g.*, let \mathcal{R} be orbitally continuous. Since \mathcal{S} and \mathcal{R} are compatible, we have

$$\lim_{n \to \infty} SRx_{2n+2} = \lim_{n \to \infty} RSx_{2n+2} = Rz. \tag{4.8}$$

From (4.7) and the orbital continuity of \mathcal{R} , we have

$$\mathcal{R}(\mathcal{R}x_n) \to \mathcal{R}z \quad \text{as } n \to \infty.$$
 (4.9)

Also, $x_{2n+1} \leq T x_{2n+1} = \mathcal{R} x_{2n+2}$. Now

$$d(SRx_{2n+2}, Tx_{2n+1}) \leq \psi \left(d(Rx_{2n+1}, RRx_{2n+2}), d(Rx_{2n+1}, Tx_{2n+1}), d(Rx_{2n+2}, SRx_{2n+2}), d(Rx_{2n+1}, SRx_{2n+2}), d(Rx_{2n+1}, SRx_{2n+2}), d(RRx_{2n+2}, Tx_{2n+1}) \right).$$

$$(4.10)$$

Passing to the limit as $n \to \infty$ in (4.10), using (4.8) and (4.9), and the continuity of ψ , if $\Re z \neq z$, we obtain

$$d(\mathcal{R}z,z) \leq \psi\left(d(\mathcal{R}z,z),0,0,d(\mathcal{R}z,z),d(\mathcal{R}z,z)\right) < d(\mathcal{R}z,z),$$

a contradiction, hence

$$\mathcal{R}z = z. \tag{4.11}$$

Now, $x_{2n+1} \leq \mathcal{T} x_{2n+1}$ and $\mathcal{T} x_{2n+1} \to z$ as $n \to \infty$, so by the assumption, we have $x_{2n+1} \leq z$ and (4.1) gives

$$d(Sz, \mathcal{T}x_{2n+1}) \leq \psi(d(\mathcal{R}x_{2n+1}, \mathcal{R}z), d(\mathcal{R}x_{2n+1}, \mathcal{T}x_{2n+1}), d(\mathcal{R}z, Sz), d(\mathcal{R}x_{2n+1}, Sz), d(\mathcal{R}z, \mathcal{T}x_{2n+1})).$$

Passing to the limit as $n \to \infty$ in the above inequality and using (4.11) and the continuity of ψ , it follows that if $Sz \neq z$,

$$d(Sz,z) < \psi(0,0,d(Sz,z),d(Sz,z),0) < d(Sz,z),$$

which is impossible. Hence,

$$Sz = z$$
.

Now, since $x_{2n} \leq Sx_{2n}$ and $Sx_{2n} \to z$ as $n \to \infty$ implies that $x_{2n} \leq z$, from (4.1)

$$d(Sx_{2n}, \mathcal{T}z) \leq \psi(d(\mathcal{R}z, \mathcal{R}x_{2n}), d(\mathcal{R}z, \mathcal{T}z), d(\mathcal{R}x_{2n}, Sx_{2n}),$$
$$d(\mathcal{R}z, Sx_{2n}), d(\mathcal{R}x_{2n}, \mathcal{T}z)).$$

Passing to the limit as $n \to \infty$, and the continuity of ψ , we obtain that if $Tz \neq z$,

$$d(z, \mathcal{T}z) \leq \psi\left(0, d(z, \mathcal{T}z), 0, 0, d(z, \mathcal{T}z)\right) < d(z, \mathcal{T}z),$$

which gives that

$$z = Tz$$
.

Therefore, Sz = Tz = Rz = z, hence z is a common fixed point of R, S, and T. The proof is similar when S is orbitally continuous.

Similarly, the result follows when the condition (b) holds.

Now, suppose that the set of common fixed points of S, T, and R is totally ordered. We claim that there is a unique common fixed point of S, T and R. Assume to the contrary that Su = Tu = Ru = u and Sv = Tv = Rv = v, but $u \neq v$. By supposition, we can replace x by u and y by v in (4.1), and by the lower semi-continuity of ψ , we obtain

$$d(v,u) = d(\mathcal{T}v, \mathcal{S}u) \le \psi \left(d(\mathcal{R}v, \mathcal{R}u), d(\mathcal{R}v, \mathcal{T}v), d(\mathcal{R}u, \mathcal{S}u), d(\mathcal{R}v, \mathcal{S}u), d(u, \mathcal{T}v) \right)$$

$$\le \psi \left(d(v,u), 0, 0, d(v,u), d(u,v) \right) < d(u,v),$$

a contradiction. Hence, u = v. The converse is trivial.

Let \mathcal{I} be the identity mapping on \mathcal{X} . Putting $\mathcal{R} = \mathcal{I}$ in Theorem 4, we obtain easily the following result.

Corollary 3 Let (X, d, \preceq) be an ordered metric space, and let T and S be self-maps on X satisfying ψ_S -contractive conditions for every pair $(x, y) \in \mathcal{O}(x_0; S, T) \times \mathcal{O}(x_0; S, T)$ (for some x_0) such that x and y are comparable.

We assume the following hypotheses:

- (i) (S, T) is a.r. at some point $x_0 \in \mathcal{X}$;
- (ii) \mathcal{X} is $(\mathcal{S}, \mathcal{T})$ -orbitally complete at x_0 ;
- (iii) T and S are weakly increasing;
- (iv) T and S are dominating maps;
- (v) S or T is orbitally continuous at x_0 .

Then S and T have a common fixed point. Moreover, the set of common fixed points of T and S is totally ordered if and only if T and S have one and only one common fixed point.

If S = T in Theorem 4, we obtain easily the following consequence.

Corollary 4 Let (X,d,\preceq) be an ordered metric space, and let T and R be self-maps on X satisfying

$$d(\mathcal{T}x,\mathcal{T}x) \leq \psi\left(d(\mathcal{R}x,\mathcal{R}y),d(\mathcal{R}x,\mathcal{T}x),d(\mathcal{R}y,\mathcal{T}y),d(\mathcal{R}x,\mathcal{T}y),d(\mathcal{R}y,\mathcal{T}x)\right)$$

for every pair $(x,y) \in \mathcal{O}(x_0; \mathcal{T}, \mathcal{R}) \times \mathcal{O}(x_0; \mathcal{T}, \mathcal{R})$ (for some x_0), where $\psi \in \mathbf{F}$ such that $\mathcal{R}x$ and $\mathcal{R}y$ are comparable.

We assume the following hypotheses:

- (i) \mathcal{T} is a.r. with respect to \mathcal{R} at $x_0 \in \mathcal{X}$;
- (ii) \mathcal{X} is $(\mathcal{T}, \mathcal{R})$ -orbitally complete at x_0 ;
- (iii) \mathcal{T} is weakly increasing with respect to \mathcal{R} ;
- (iv) T is a dominating map;
- (v) \mathcal{T} or \mathcal{R} is orbitally continuous at x_0 .

Then T and R have a common fixed point. Moreover, the set of common fixed points of T and R is totally ordered if and only if T and R have one and only one common fixed point.

Let \mathcal{I} be the identity mapping on \mathcal{X} . Putting $\mathcal{R} = \mathcal{I}$ in Corollary 4, we obtain easily the following consequence.

Corollary 5 Let (X, d, \preceq) be an ordered metric space, and let T be a self-map on X satisfying

$$d(\mathcal{T}x, \mathcal{T}x) \le \psi(d(x, y), d(x, \mathcal{T}x), d(y, \mathcal{T}y), d(x, \mathcal{T}y), d(y, \mathcal{T}x))$$

for every pair $(x,y) \in \mathcal{O}(x_0;\mathcal{T}) \times \mathcal{O}(x_0;\mathcal{T})$ (for some x_0) such that x and y are comparable. We assume the following hypotheses:

- (i) \mathcal{T} is a.r. at some point $x_0 \in \mathcal{X}$;
- (ii) \mathcal{X} is \mathcal{T} -orbitally complete at x_0 ;
- (iii) $\mathcal{T}x \leq \mathcal{T}(\mathcal{T}x)$ for all $x \in \mathcal{X}$;
- (iv) \mathcal{T} is a dominating map;
- (v) \mathcal{T} is orbitally continuous at x_0 .

Then T has a fixed point. Moreover, the set of fixed points of T is totally ordered if and only if it is a singleton.

The following example demonstrates the validity of Theorem 4.

Example 6 Let the set $\mathcal{X} = [0, +\infty)$ be equipped with the usual metric d and the order defined by

$$x \leq y \iff x = y \vee (x, y \in [0, 1] \land x \geq y).$$

Consider the following self-mappings on \mathcal{X} :

$$\mathcal{R}x = 6x, \qquad \mathcal{S}x = \begin{cases} \frac{1}{2}x, & 0 \le x \le \frac{1}{2}, \\ x, & x > \frac{1}{2}, \end{cases} \qquad \mathcal{T}x = \begin{cases} \frac{1}{3}x, & 0 \le x \le \frac{1}{3}, \\ x, & x > \frac{1}{3}. \end{cases}$$

Take $x_0 = \frac{1}{2}$. Then it is easy to show that all the conditions (i)-(iv) and (a)-(b) of Theorem 4 are fulfilled (the condition (iii) on $O(x_0; \mathcal{S}, \mathcal{T}, \mathcal{R})$). Take $\psi : \mathbb{R}^{+5} \to \mathbb{R}^+$ given by

$$\psi(t_1, t_2, t_3, t_4, t_5) = \frac{1}{6} \max \left\{ t_1, t_2, t_3, \frac{t_4}{2}, \frac{t_5}{2} \right\},\,$$

and $\psi \in \mathbf{F}$. Then the contractive condition (4.1) takes the form

$$\left| \frac{1}{2}x - \frac{1}{3}y \right| \le \frac{1}{6} \max \left\{ |6x - 6y|, \frac{11}{2}x, \frac{17}{3}y, \frac{1}{2} \left| 6x - \frac{1}{3}y \right|, \frac{1}{2} \left| 6y - \frac{1}{2}x \right| \right\},$$

for $x, y \in O(x_0; S, T, R)$. Using substitution $y = tx, t \ge 0$, the last inequality reduces to

$$|3-2t| \leq \max\left\{6|1-t|, \frac{11}{2}, \frac{17}{3}t, \frac{1}{2}\left|6-\frac{1}{3}t\right|, \frac{1}{2}\left|6t-\frac{1}{2}\right|\right\},\,$$

and can be checked by discussion on possible values for $t \ge 0$. Hence, all the conditions of Theorem 4 are satisfied and S, T, R have a common fixed point (which is 0).

5 Existence of a common solution of integral equations

Consider the system of integral equations:

$$\begin{cases} u(t) = \int_0^T K_1(t, s, u(s)) \, ds, & t \in [0, T], \\ u(t) = \int_0^T K_2(t, s, u(s)) \, ds, & t \in [0, T], \end{cases}$$
(5.1)

where T > 0 and $K_1, K_2 : [0; T] \times [0; T] \times \mathbb{R} \to \mathbb{R}$ are continuous functions. The purpose of this section is to give an existence theorem for a solution of (5.1).

We consider the set $C(I,\mathbb{R})$ (I = [0,T]) of real continuous functions defined on I. This set with the metric given by

$$d(u,v) = \max_{t \in I} |u(t) - v(t)|, \quad \forall u, v \in C(I, \mathbb{R}),$$

is a complete metric space. $C(I,\mathbb{R})$ can also be equipped with the partial order \leq given by

$$u, v \in C(I, \mathbb{R}), \quad u \leq v \quad \Leftrightarrow \quad u(t) \leq v(t), \quad \forall t \in I.$$

Moreover, in [7] it is proved that $(C(I, \mathbb{R}), d, \leq)$ is regular. Consider the mappings $\mathcal{T}, \mathcal{S} : C(I, \mathbb{R}) \to C(I, \mathbb{R})$ defined by

$$\mathcal{T}u(t) = \int_0^T K_1(t, s, u(s)) ds$$
, for all $C(I, \mathbb{R}), t \in I$,

$$Su(t) = \int_0^T K_2(t, s, u(s)) ds$$
, for all $C(I, \mathbb{R}), t \in I$.

Clearly, u is a solution of (5.1) if and only if it is a common fixed point of \mathcal{T} and \mathcal{S} .

We shall prove the existence of a common fixed point of $\mathcal T$ and $\mathcal S$ under certain conditions.

Theorem 5 Suppose that the following hypotheses hold:

(H1) for all $t, s \in I$, $u \in C(I, \mathbb{R})$, we have

$$K_1(t,s,u(s)) \leq K_2(t,s,\int_0^T K_1(s,\tau,u(\tau)) d\tau);$$

(H2) for all $t, s \in I$, $u \in C(I, \mathbb{R})$, we have

$$K_2(t,s,u(s)) \leq K_1(t,s,\int_0^T K_2(s,\tau,u(\tau)) d\tau);$$

(H3) there exist a continuous function $\alpha: I \times I \to \mathbb{R}^+$ and $\psi \in \mathbf{F}$ such that

$$|K_1(t, s, x(s)) - K_2(t, s, y(s))|$$

$$\leq \alpha(t, s)\psi(d(x, y), d(x, \mathcal{T}x), d(y, \mathcal{S}y), d(x, \mathcal{S}y), d(y, \mathcal{T}x))$$

for all $t, s \in I$ and $x, y \in C(I, \mathbb{R})$ such that $x \succeq y$;

(H4) $\sup_{t \in I} \int_0^T \alpha(t, s) ds \le 1$.

Then the system of integral equations (5.1) has a solution $u^* \in C(I, \mathbb{R})$.

Proof Let $u \in C(I, \mathbb{R})$. Using (H1), for all $t \in I$, we have

$$\mathcal{T}u(t) = \int_0^T K_1(t, s, u(s)) ds$$

$$\leq \int_0^T K_2(t, s, \int_0^T K_1(s, \tau, u(\tau))) d\tau ds$$

$$= \int_0^T K_2(t, s, \mathcal{T}u(s)) ds$$

$$= \mathcal{S}\mathcal{T}u(t).$$

Similarly, using (H2), for all $t \in I$, we have

$$Su(t) = \int_0^T K_2(t, s, u(s)) ds$$

$$\leq \int_0^T K_1(t, s, \int_0^T K_2(s, \tau, u(\tau)) d\tau) ds$$

$$= \int_0^T K_1(t, s, Su(s)) ds$$

$$= \mathcal{T}Su(t).$$

Then we have $\mathcal{T}u \leq \mathcal{S}\mathcal{T}u$ and $\mathcal{S}u \leq \mathcal{T}\mathcal{S}u$ for all $u \in C(I, \mathbb{R})$. This implies that \mathcal{T} and \mathcal{S} are weakly increasing.

Now, for all $u, v \in C(I, \mathbb{R})$ such that $v \leq u$, by (H3) and (H4), we have

$$\begin{aligned} & \left| \mathcal{T}u(t) - \mathcal{S}v(t) \right| \\ & \leq \int_0^T \left| K_1(t, s, u(s)) - K_2(t, s, v(s)) \right| ds \\ & \leq \int_0^T \alpha(t, s) \psi \left(d(u, v), d(u, \mathcal{T}u), d(v, \mathcal{S}v), d(u, \mathcal{S}v), d(v, \mathcal{T}u) \right) ds \\ & = \left(\int_0^T \alpha(t, s) \, ds \right) \psi \left(d(u, v), d(u, \mathcal{T}u), d(v, \mathcal{S}v), d(u, \mathcal{S}v), d(v, \mathcal{T}u) \right) \\ & \leq \psi \left(d(u, v), d(u, \mathcal{T}u), d(v, \mathcal{S}v), d(u, \mathcal{S}v), d(v, \mathcal{T}u) \right). \end{aligned}$$

Hence, we have proved that for all $u, v \in C(I, \mathbb{R})$ such that $u \succeq v$, we have

$$d(\mathcal{T}u, \mathcal{S}v) < \psi(d(u, v), d(u, \mathcal{T}u), d(v, \mathcal{S}v), d(u, \mathcal{S}v), d(v, \mathcal{T}u)).$$

Now, all the hypotheses of Corollary 1 are satisfied. Then \mathcal{T} and \mathcal{S} have a common fixed point $u^* \in C(I, \mathbb{R})$, that is, u^* is a solution of the system (5.1).
